

Event Terms and Conditions 活動須知事項

Enrolment 報名

- Upon submitting the Enrolment Form with signature, a participant is deemed to have accepted all Terms and Conditions of the programme. 遞交已簽署之報名表格即表示參加者知悉、接受及將遵守所有須知事項。
- A completed Enrolment Form and a non-refundable and non-transferable programme fee have to be submitted for reservation. (Please make cheque payable to "VIENNA BOYS CHOIR MUSIC ACADEMY FOUNDATION LIMITED") 請將填妥之報名表連同課程費用 (支票抬頭:維也納兒童合唱團音樂學院基金有限公司),於報名時一併遞交以辦理留位手續。所繳費用不予發還,亦不得轉予他人。
- Enrolment is processed on a first come, first served basis. 課程報名以先到先得方式處理。
- If the number of participant cannot meet the minimum requirement, Vienna Boys Choir Music Academy Foundation (VBCMAF) reserves the right to reschedule or to cancel the programme. 如未達最低參加人數,維也納兒童合唱團音樂學院基金(基金)保留更改課程時間或取消課程的權利。

Health Condition 身體狀況

- Participants with temperature higher than 37.8 C should not attend any programme. VBCMAF reserves the right to reject the admission or attendance of participants who are in bad health conditions. 體溫超過37.8攝氏度的參加者不應參與課堂。基金保留拒絕身體狀況不適宜參加者進入或繼續課堂的權利。

Inclement Weather Conditions 惡劣天氣

- When Tropical Cyclone Warning Signal No.8 or above is hoisted within 3 hours of the start of the programmes, such programmes will be cancelled. When Tropical Cyclone Warning Signal No.8 or above is hoisted during the programmes, the programmes will continue until the end of such programmes. 如八號或以上熱帶氣旋警告信號於課堂開始前三小時內懸掛,課堂將會被取消。如八號或以上熱帶氣旋警告信號於課堂進行時懸掛,課堂將繼續進行至原定結束時間。
- When Black Rainstorm Warning Signal is issued within 3 hours of the start of the programmes, such programmes will be cancelled. When Black Rainstorm Warning Signal is issued during the programmes, the programmes will continue until the end of such programmes. 如黑色暴雨警告信號於課堂開始前三小時內發出,課堂將會被取消。如黑色暴雨警告信號於課堂進行時發出,課堂將繼續進行至原定結束時間。
- All programmes will be resumed 3 hours after Tropical Cyclone No.8 or above / Black Rainstorm Warning Signal is cancelled by the Hong Kong Observatory. 如八號或以上熱帶氣旋警告信號/ 黑色暴雨警告信號被取消,課程將於三小時後照常進行。
- Participants should consider the actual weather and traffic condition when deciding whether or not to attend the programmes. 參加者應根據實際天氣及交通情況,決定是否前往上課地點。

Make-up session or Refund 補堂或退款

- No make-up will be arranged except programmes cancelled by VBCMAF. 除基金改動課程時間以外,不設補堂。
- All kinds of leave or further change request will not be entertained in make-up class. No make-up will be arranged for those who are absent for a make-up session. 補堂不設轉換日期或時段。未能出席者作自動放棄補堂論。
- No refund for any participant withdraws from the Programme. 如參加者退出課程,所繳費用恕不退還。
- No make-ups or refund will be arranged for programme alteration or cancellation due to inclement weather conditions or other enforced closures beyond control of VBCMAF. 如因惡劣天氣等非基金所能控制之情況引致課程更改或取消,恕不補堂或退還款項。

Photos, Video and Audio Recordings 攝影、錄影及錄音

- No photo-taking, video-taking or audio recording is allowed during the programmes or activities unless prior written consent is obtained from VBCMAF. 除事先取得基金書面同意外,課程或活動中不得攝影、錄影或錄音。
- VBCMAF reserves the right to take images, videos, sound recordings during classes, performances or related activities. All images, videos, sound recordings will belong to the property of VBCMAF. VBCMAF reserves the right to use the images, videos, recordings for any lawful purposes including but not limited to displays, exhibition, advertising, websites, editorials and promotional materials at any time in the future without the need to seek further permission. 基金保留於課堂、表演或相關活動中攝影、錄影及錄音的權利。所有相片、影片及錄音之版權均屬基金所有。基金有權使用該等相片、影片及錄音作任何合法用途,包括但不限於展示、展覽、廣告、網站、廣播及宣傳材料,不作另行通知。

Responsibilities 責任

- Participants shall indemnify and/or reimburse VBCMAF in respect of any additional expenses or costs incurred by VBCMAF arising from or in connection with the fault or action or behaviour of participants. 如參加者在活動期間因蓄意破壞而導致基金支付額外開支,須對基金作出合理賠償。
- All participants enrolled in activities do so at their own risk and VBCMAF is not responsible for any loss, damage, injury or death to participants or their guests as a result of participating in the activities. 課程屬自願參與性質,參與者願意承擔一切風險及責任,如參加者或其同伴因參與課程而導致財物遺失、損失或傷亡,主辦單位概不對該等遺失、損失或傷亡負責。
- Participation should comply the law in Hong Kong Special Administration Region. The organiser is not responsible to participants' violation of law. 參加者須遵守香港特別行政區法律。主辦單位對參加者任何違反法律的事情,概不負責。
- VBCMAF reserves the absolute right to change or amend any of the above Terms and Conditions, to change, cancel or withdraw any of program / activity arrangement, privileges and promotions any time without prior notice and without incurring liability to any party whatsoever. 基金有權對上述條款及細則作出更改,及有權對任何課程、課堂、補堂、優惠及推廣作出更改或中止而無須事先通知或對任何一方上任何責任。
- Should there be disputes, VBCMAF reserve the right to the final decision. 如有任何爭議,基金保留最終決定權。
